

AUTOMOTIVE MEETINGS QUERETARO 2015 GENERAL TERMS AND CONDITIONS

1. ORGANISATION

The AUTOMOTIVE MEETINGS QUERETARO 2015 business convention is organized by the company abe - advanced business events, a limited company with a stated capital of 50.000 Euros, whose registered head office is located at 35/37 rue des Abondances - 92513 BOULOGNE-CEDEX - France, hereafter referred to as the organizers.

2. PURPOSE

These regulations stipulate the terms and conditions according to which the organizers run the above convention. They detail the respective rights and obligations on the part of the delegate and the organizers. The delegate formally undertakes to abide by these regulations.

3. PLACE AND DATE

The AUTOMOTIVE MEETINGS QUERETARO 2015 business convention will be held at the Querétaro Congress Center from **February 23th to 25th, 2015**. The organizers are free to change the place or date of the convention in the event of the premises being unavailable in case of *force majeure*. The organizers are free to cancel the convention having first notified the delegate, in which case ongoing registration applications shall be cancelled ipso jure, without any compensation due to the delegate except the refund of pre-paid registration fees.

4. ADMISSION, REGISTRATION, CANCELLATION, PAYMENT

Any company or institution is entitled to participate provided it has the relevant skills to enter into negotiations with prime contractors. The organizers reserve the right to refuse any application, whatever the grounds and without having to justify their decision. In the event of a delegate withdrawing before January 4th 2015, the signatory is liable for 30% of the initial participation fee, to cover the organizers' costs. Withdrawal from the event can only be notified to the organizers by registered letter with acknowledgement of receipt, the postmark being taken as proof of postage. After that date, registration for AUTOMOTIVE MEETINGS QUERETARO 2015 is considered final and irrevocable, and the delegate is liable for the whole of the initial amount for participation.

5. SERVICES INCLUDED IN THE OVERALL PARTICIPATION FEE

The overall participation fee is **\$ 3.300 USD***, **\$ 4.500 USD***, **\$ 9.000 USD*** depending on the basic option chosen, plus any additional options. This registration fee for the AUTOMOTIVE MEETINGS QUERETARO 2015 business convention includes the items described in the "Basic, Executive and Premium packages" section of the present registration form.

6. COMMERCIAL REGULATIONS

Delegates may not allow any other company to benefit from the services offered by the AUTOMOTIVE MEETINGS QUERETARO 2015 business convention without prior consent from the organizers. Delegates formally undertake not to perform activities outside the confines of the convention center premises similar to those offered within, and this for the whole duration of the convention.

7. OBLIGATION TO PRODUCE A RESULT

The organizers undertake to diligently use the resources available to it without being subject to an obligation to produce a result.

8. INSURANCE

The organizers are legally responsible as organizers of the AUTOMOTIVE MEETINGS QUERETARO 2015 business convention. This civil liability shall under no circumstances be extended to include injury caused by third parties to delegates. The Querétaro Congress Center (Querétaro, Mexico) assumes its civil liability as owner of the fixtures and fittings, permanent or otherwise, used for the purposes of the convention, and for the use of companies and business activities under its direct control. The same applies to all outside companies. Delegates must have delegational liability insurance cover and must undertake to answer for all damages caused to others either by themselves or their staff or equipment. Delegates must have insurance cover for any equipment they own or acquire during the convention.

9. APPLICATION OF THE REGULATIONS

The organizers reserve the right to decide on all cases not provided for in these regulations and to introduce any necessary amendments or additional clauses to this matter, which shall become immediately enforceable. Circulars sent out to delegates at a later date form an integral part of these regulations. Any infringement of these regulations may lead to the expulsion of the offender/infringing party, at the sole request of the organizers, without formal notice and no refund shall be due for the participation fee nor for any sums paid by him, which shall be retained by the organizers.

10. JURISDICTION CLAUSE

By signing the registration form, the delegate shall be deemed to have agreed to be bound unreservedly by the clauses of these regulations. In the event of a dispute and before any proceedings are instituted, the delegate undertakes to submit his complaints to the organizers. In the event of a dispute, the courts assigned to the registered offices of the abe shall entertain sole jurisdiction.
